- advising lenders on the construction documentation for a £36 million development of student accommodation for a leading university, including reviewing and negotiating the building contract, appointments, collateral warranties and other security documentation
- representing a multinational supplier and manufacturer of construction products in connection with a complex, multi-party claim in the Technology and Construction Court relating to alleged defects in gas pipework at a residential development
- acting for developers and investment funds on the procurement of a number of EPC and EPCM waste to energy plants. One of our clients secured the UK's first Green Investment Bank loan in relation to its 5MW plant
- advising on the draft construction contract and facilities management contracts, warranties and security arrangements on behalf of the funder of a development of a London post graduate student accommodation project with a value of £50 million

Our team was instrumental in negotiating changes to the drafts which satisfied not only the lenders but were also acceptable to the contractors and consultants
- advising a bio-energy company on its contracts for the development of an anaerobic digester on leased agricultural land on a number of sites. Our work included advising on the form of process engineering contract to be used for the project
- acting for the lenders in the financing of a local authority PFI scheme for the design and construction of four new build fire stations and five refurbished fire stations in Suffolk
- advising a property owner/investor in relation to a claim for defectively designed and installed air conditioning systems in an office building in Leeds. Our role included bringing claims under collateral warranties issued by the main design and build contractor
